

## Multi-Employer Plans: Approved Applications for Waiver of the Annual Limits Requirements

Updated March 4, 2011

These plans are multi-employer group health plans created by a collective bargaining agreement between a union and employers, under the Taft Hartley Act. This type of fund is made up of contributions from both the employers and employees. The size of the fund and contribution levels are negotiated and vary among plans. They tend to be larger than other typical group health plans because they cover multiple employers. Both the union and the employer are trustees or managers of the fund. The fund is used for the employees' health coverage.
